2008 serial blasts: Gujarat HC admits plea for death penalty confirmation



AHMEDABAD: The Gujarat High Court on Thursday

admitted an application filed by the state government seeking confirmation of death penalty awarded by a special court in February to 38 convicts in the 2008 serial blasts case, in which 56 persons were killed and over 200 others sustained injuries in different parts of the city on July 26, 2008 evening. A bench of Justice V M Pancholi and Justice S N Bhatt admitted the government's plea and decided to hear it with the appeals that the convicts are likely to file against their conviction. He condemned 38 persons to death and awarded life imprisonment to 11 others. The court had acquitted 28 persons by giving them the benefit of doubt for want of evidence. The court also granted pardon to one accused, who turned an approver and supported the prosecution's case.

Public prosecutor Mitesh Amin also submitted that the high court may hear all the cases together once the convicts file their appeals. He also informed the court that few convicts, who are lodged in different jails, have refused to accept the court notice.

On February 8, special judge A R Patel convicted 49 persons guilty of 78 who were put on the trial for the terror strike. A bench of Justice V M Pancholi and Justice S N Bhatt admitted the government's plea and decided to hear it with the appeals that the convicts are likely to file against their conviction.

He condemned 38 persons to death and awarded life imprisonment to 11 others. The court had acquitted 28 persons by giving them the benefit of doubt for want of evidence. The court also granted pardon to one accused, who turned an approver and supported the prosecution's case.

INDIAN REFRIGERATION MARKET IS EXPECTED TO GROW MORE




